- 4. An abstention (or "vote withheld") option has been included on this form of proxy. The legal effect of choosing the abstention option on any resolution is that the shareholder concerned will be treated as not having voted on the relevant resolution. The number of votes in respect of which there are abstentions will however be counted and recorded, but disregarded in calculating the number of votes for or against each resolution.

    of such member; and
  - (b) a corporation, this proxy form must be executed under its common seal or signed on its behalf by an officer of the corporation or a duly appointed attorney for the corporation.
- . To appoint a proxy using this form, the form must be:
  - (a) completed and signed;
  - (b) sent or delivered to the Company's Registrars, Equiniti Limited, at Aspect House, Spencer Road, Lancing, BN99 6DA; and
  - (c) received by the Company's Registrars no later than 48 hours (excluding non-working days) before the time appointed for the meeting, or adjourned meeting, at which it is to be used.
- Any power of attorney or any other authority under which this proxy form is signed (or a duly certified copy of such power or authority) must be included with the proxy form.
- 8. Any alteration to this proxy form must be initialled by the person in whose hand it is signed or executed.
- 9. If, after returning a duly completed proxy form, you wish to revoke your proxy appointment you must sign and date a notice clearly stating your intention to revoke that proxy appointment and deposit it at the office of the Company's Registrars, Equiniti Limited, at Aspect House, Spencer Road, Lancing, BN99 6DA before the time appointed for the meeting.
- 10. CREST members can submit their proxy through the CREST Electronic Proxy Appointment Service (ID RA19).
- 11. In the case of joint holders:
  - (a) where more than one of the joint holders purports to appoint a proxy, only the appointment submitted by the most senior holder will be accented; and
  - (b) the vote of the most senior holder who tenders a vote (whether in person or by proxy) shall be accepted to the exclusion of the votes of all other joint holders.

Seniority is determined by the order in which the names of the joint holders appear in the Company's register of members in respect of the joint holding (the first-named being the most senior).

- 12. The right to appoint a proxy does not apply to persons whose shares are held on their behalf by another person and who have been nominated to receive communication from the Company in accordance with section 146 of the Act ("nominated persons"). Nominated persons may have a right under an agreement with the registered shareholder who holds shares on their behalf to be appointed (or to have someone else appointed) as a proxy. Alternatively, if nominated persons do not have such a right, or do not wish to exercise it, they may have a right under such agreement to give instructions to the registered shareholder as to the exercise of voting rights.
- 13. Pursuant to Regulation 41 of the Uncertificated Securities Regulations 2001, the Company gives notice that only those shareholders entered on the register of members of the Company at 6.30 p.m. on 12 March 2024 will be entitled to attend or vote (whether in person or proxy) at the Annual General Meeting in respect of the number of shares registered in their name at that time. Changes to entries on the register after 6.30 p.m. on 12 March 2024 will be disregarded in determining the rights of any person to attend or vote at the meeting or any adjourned meeting (as the case may be).
